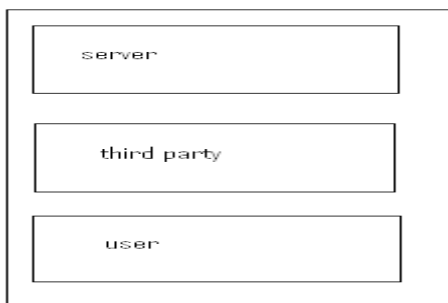


Fig 1: Shows the block diagram of the present method respectively
