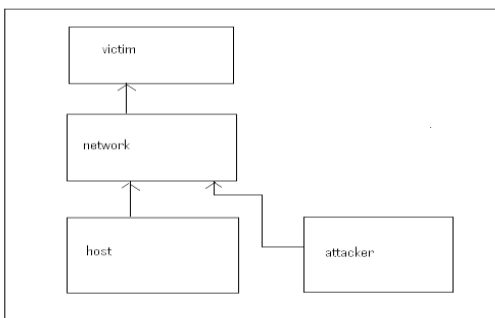


Fig 1: Shows the block diagram of the present method respectively

3. EXPECTED RESULTS:

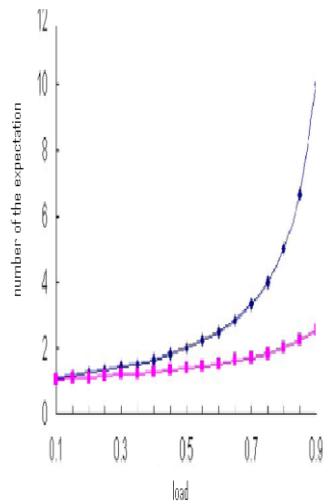


Fig 2: Shows the graphical representation of the present method respectively
