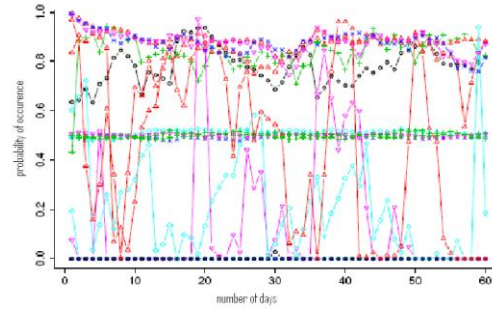


Fig 1: Shows the graphical representation of the probability based occurrence

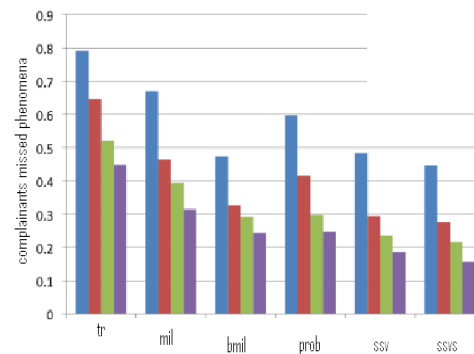


Fig 2: Shows the parameter oriented missed rate
