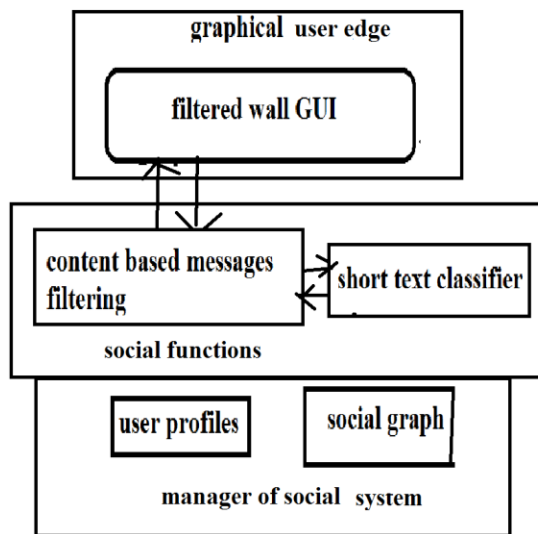


Fig1: An overview of Filtered wall conceptual design
