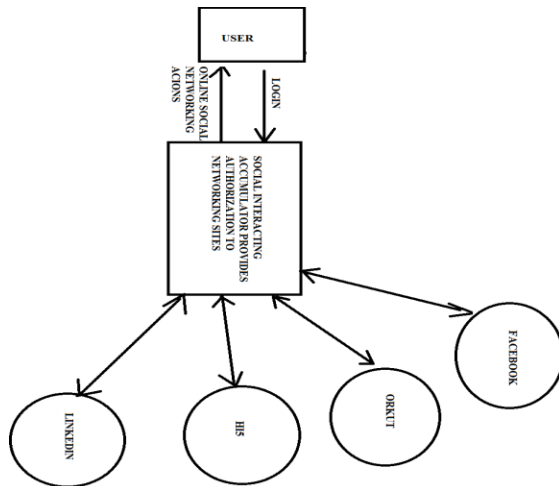
### 1. INTRODUCTION:
