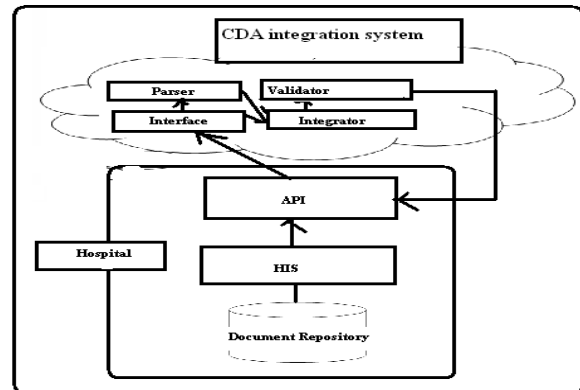


Fig.1. Overview of architecture
