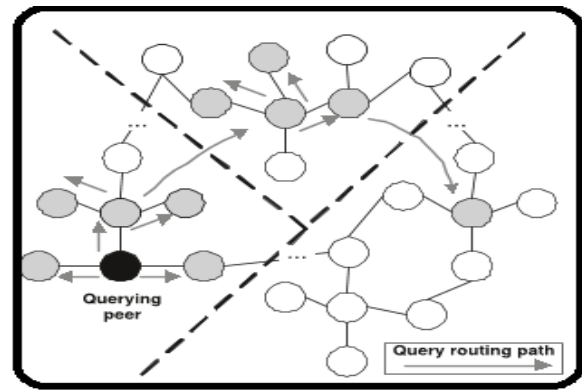


Fig.1. Proposed system framework
