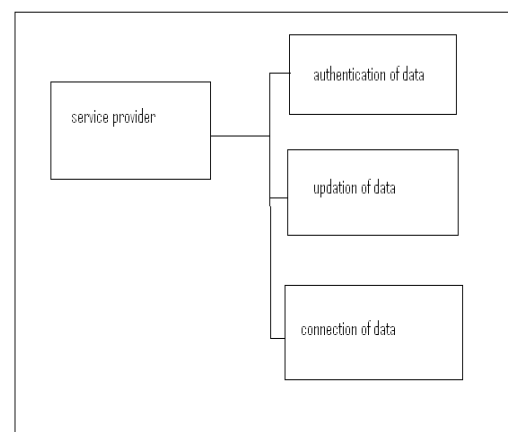

**Fig 1: Shows the block diagram of present technique respectively**

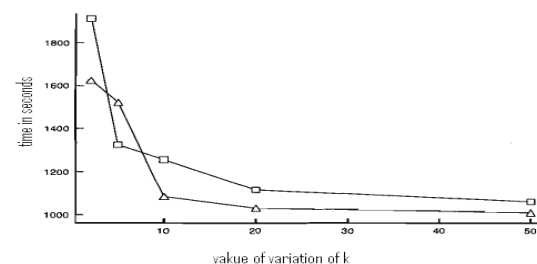
## 2. METHODOLOGY
