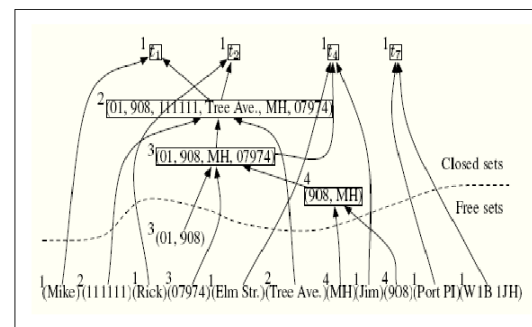

**Fig 1: Shows the representation of the present method respectively**

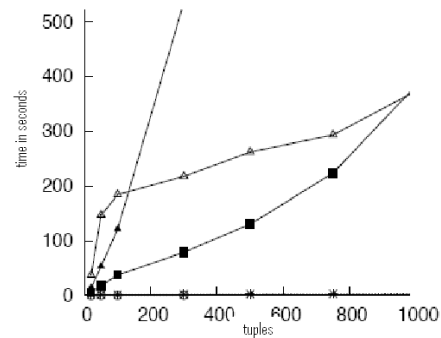
## 2. METHODOLOGY
