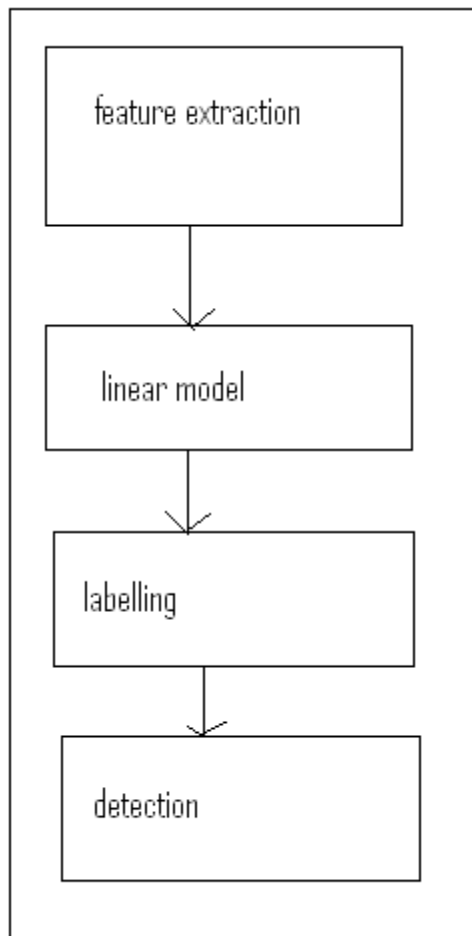


Fig 1: Shows the block diagram of the present method respectively

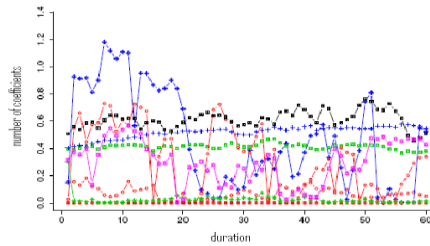


Fig 2: Shows the graphical representation of the present method respectively
